Billing Policy

Swim practices meet at the published times, either on the website, email, or newsletter. Rates are a monthly fee, whether swimmers are present or not. Pro-Rating is only available for members beginning mid-month or mid-season. Cancellations and refunds may not be made for vacations, team breaks, or holidays. Only medical excuses from a doctor will relieve you from payment obligation. You will be put on an automatic billing system. **Monthly swimmers wishing to stop swim team, must turn in a "Cancellation Form" within 2 weeks of the next billing cycle (20th of the month).** The Cancellation form requires your signature, date of cancellation, and coach's signature. The cancellation form is available through the swim coach.

*** ANNUAL: Beginning September and ending in August. Swimmers are signing up for an annual season at the special discounted monthly rate listed above. Swimmers signing up are responsible for 12 months of dues whether swimmer is present or not. Swimmers who qualify to cancel from annual payments will be responsible for back payment of dues at the monthly rate additional cost. Please see the Billing policy on the following page referring to who qualifies to cancel annual payments.

*** MONTHLY: Swimmers who cannot commit to one year or season can pay the monthly rate listed above. Swimmers cannot change to annual swim team under any circumstances. Swimmers may only start the annual payments beginning in September and cannot receive the discount thereafter. For demand reasons, the monthly dues from May – Aug are fixed slightly higher. The accounting office will show this change on your statement.

***SEASONAL: Swimmers that chose this option can swim for each season at a time and cannot join with the annual season until September, 2011. Seasonal swimmers will swim for an announced season, this means that the swimmers will only be allowed to participate during the posted dates. Swimmers who wish to renew from Season to Season do not have to complete a separate form. Swimmers that attend practice/meet dates after the season end date will be charged the seasonal rate for the following season.

Procedure for Disciplinary Action

The Head Coach should always be notified about any problems or concerns with swimmers, coaches and/or parents. Below are the procedures for disciplinary action for swimmers.

1. The swimmer receives a verbal warning from the coach.
2. The swimmer will be asked to sit out of the pool on the deck. This may include some physical activity including, push-ups, sit-ups or lunges, (age appropriate).
3. The swimmer will be asked to leave the pool area and the Head Coach will contact the parent.

Parent Commitment to Volunteer

Parent cooperation and volunteer efforts makes the swim season possible and fun for everyone. Each family is required to participate and donate time to The Hills Swim Team competition season. If the family obligation is not met, there is a required **\$100 donation** for exemption from volunteering. **Please initial each section below:**

- Volunteer for 2 shifts at every home meet, including all meets.
Shifts are 4 hours in length. This volunteer responsibility happens 2 to 3 times per year.
[*or any satellite affiliation under which the Hills swims. Additional volunteer shifts may also be required but are not currently specified at this time.]
- At away swim meets, volunteer at least one hour of timing per family. Away meet set up and take down (parents will be asked to sign up to volunteer to deliver and set up/take down and return team canopies at away meets).
- Participate in all fundraising activities, including swim-a-thon, sales, or auction (families that do not wish to participate must pay the \$100 donation).

I understand that my family is responsible for participation and volunteer time. I will pay \$100 donation to The Hills Swim Team for volunteer exemption, determined by the head coach and volunteer coordinator.

PARTICIPATION WAIVER

Medical Authorization and Consent to Treat

Pursuant to California Family Code §§ 6550 and 6910, I, [REDACTED], a parent or legal guardian having legal custody of [REDACTED], a minor child, hereby authorize The Hills Swim and Tennis Club, to consent to any X-ray examination (or similar examination such as by CAT/MRI scan), anesthetic, medical, dental, or surgical diagnosis or treatment and hospital care to be rendered to the minor under the general or special supervision of a qualified physician, surgeon, or dentist I agree to pay any and all costs for the foregoing. I have no knowledge of any physical or mental impairment that would affect the Participant's ability to participate in this activity.

Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement

I, the Buyer, on my own behalf, on behalf of all those who are listed as participants under this Agreement, including my minor children and, my/their personal representatives, assigns, successors, heirs, and next of kin (hereinafter collectively referred to as "the Releasers") acknowledge and agree that the use of the facilities, services, equipment, or premises of The Hills Swim and Tennis Club (The "Club") by the Releasers involves risk of injury to persons and property. The Releasers assume full responsibility for such risks for myself/themselves. In consideration of being permitted to enter and use the Club's facilities for any purpose, including, but not limited to, observation, services, equipment, training, or participation in any way, the Releasers agree to the following: the Releasers do hereby release and hold harmless the Club, its directors, officers, shareholders, parents, subsidiaries, employees, independent contractors, and agents from all liability to the Releasers, for any loss or damage. The Releasers waive, any claim or demands therefore based on, or on account of, any physical or mental injury or death to any of the Releasers and property damages, including theft, sustained by any Releasers, whether caused by the active or passive negligence of the Club or otherwise. This release of liability includes, but is not limited to claims based on the following: the Club's improper maintenance of its equipment (mechanical or otherwise), grounds or facilities; the Club's negligent instruction or supervision, including personal training, or inadequate security or staffing while any of the Releasers is in, upon, or about the Club's premises; the Releasers' use of the Club's facilities, services, or equipment; and/or slipping or tripping anywhere in or about the Club. Such facilities include, but are not limited to: exercise equipment, locker rooms, sidewalks, parking lots, stairs, pool, whirlpool, spa, sauna, steam room, tennis/racquet courts, or lobby area. Such risk of injury includes, but is not limited to injuries arising from the participation by any of the Releasers or others in supervised or unsupervised activities at the Club, injuries and medical disorders, including, but not limited to death, heart attacks, strokes, heat stress, sprains, broken bones, and torn muscles and ligaments, among others, arising from exercising or any recreational use of any of the Club's facilities or while participating in any of the Club's programs, and accidental injuries occurring anywhere in or about the Club, including its dressing rooms, showers and other facilities. The Releasers also agree to indemnify the Club from any loss, liability, damage or cost that the Club may incur due to the presence of any of the Releasers in, upon or about the Club's premises or in any way observing or using any of the Club's facilities, services or equipment, whether caused by the Releasers' negligence or otherwise. The Releasers expressly agree that the foregoing Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement is intended to be as broad and as inclusive as permitted by the law of the state of California, and that if any portion of the foregoing Assumption Of Risk And Liability Waiver And Release and Indemnity Agreement is held invalid, then it is agreed that the remainder of this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement shall continue in full force and effect.

I acknowledge that I have carefully read this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement and fully understand that it is a release of liability, and express assumption of risk and indemnity agreement. I am aware and agree that by executing this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement, I, and all the Releasers are giving up any rights I/they may have to bring a legal action or assert a claim against the Club for its negligence, or for any defective product on its premises.

I represent that I have the actual authority to, and do hereby enter into this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement on my behalf and as an authorized agent or parent or legal guardian for all of the Releasers. I have read and voluntarily signed this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement and I further agree that no oral representations, statements or inducement apart from the foregoing written agreement have been made to me or any of the Releasers.

I have read and agree to be bound by the terms of this Assumption Of Risk And Liability Waiver And Release And Indemnity Agreement and the Membership Agreement. I further agree to be bound by the Club's Rules and Regulations.
